Executive Director Report

Executive Director Kyles-Smith opened by sharing that Two Rivers suggested that the Board move forward in partnership with the NorthBay Sole Source Contract based on the Memo that was earlier shared with the Board of Trustees.

In October 2021, Two Rivers Middle School students faced incidents of racism while attending the annual crew building experience at NorthBay. Subsequently, Two Rivers reflected on the impact of programming that NorthBay provided, looked at alternative options, and discussed the recommendation to move forward with NorthBay.

Middle School Assistant Principal of Culture Baecker outlined the follow-up that NorthBay has done in response to Two Rivers requests including an outward statement of anti-racism and a DEI training of staff. Since then, a statement has been placed on the NorthBay website and a three-week DEI training is being undertaken by NorthBay Staff. Additionally, NorthBay staff have invited Two Rivers staff and students to lead part of the training.

NorthBay Director of Education Garber shared that the organization, including staff and Board of Trustees, are excited to grow together and share in opportunity and partnership.

A discussion occurred among Trustees and Garber with questions regarding prior racist incidents, the outcome of what happened to staff involved in the racist incident, and efforts to diversify staff.

Executive Director Kyles-Smith brought up the second incident regarding the passing of Athumani Brown while at NorthBay in early June. Garber shared that NorthBay had reviewed the incident and did a risk assessment of everything from the time that Athumani arrived at camp. They found that every step they took was best practice. They have implemented additional measures such as having extra water stations and accountability for water breaks. They also have 24-hour medical staff with an RN during the day and CNA/EMT overnight.

The Board of Trustees unanimously voted to approve the NorthBay Sole Source Contract.

Closed Session

The Board of Trustees unanimously voted to move to Closed Session under Open Meetings Act D.C. Code Section 2-575(b)(4)(A) to consult with counsel and obtain legal advice.

The Board of Trustees unanimously voted to move to Open Session.

Adjournment

The Board meeting adjourned at 8:58 PM.
