Approval of Meeting Agenda

All Trustees voted to approve the August 10th, 2024 agenda.

Opening Circle

Executive Director Reaves opened the meeting with reading of the Two Rivers Mission, Goal, and Core Values. Trustees proceeded to have a discussion around assumptions, agreements, arguments and aspirations reflecting on the Mission, Goal, Core Values, and Race and Equity Statement.

Session 1: Summer Reading

Trustees held table discussions around the book <u>Great on their Behalf</u>. Each table came up with a positive, newsworthy headline based on the book's overarching theme. Themes resonate around using data to support students. Trustees held a discussion on focusing on student numbers beyond the headline and stamping that the Board and Executive Director are on the same page.

Session II: Strategic Plan Goal #1

Executive Director Reaves shared Strategic Plan Goal #1 is focused on academic growth, with a focus on using EL Education's three dimensions of student achievement. In Reading and English Language Arts, proficiency remains stable throughout the year with slight increase by Spring. The data suggests a need for targeted interventions to improve growth metrics in Reading/ELA and an emphasis on differentiated instruction. Two Rivers will be prioritizing professional learning with a focus on strategies to enhance student growth in ELA. In Math, there was an increase in the percentage of students meeting growth goals in Spring. The data suggests an opportunity to prioritize support for students in the lower quartiles and sustaining the growth in higher quartiles. Two Rivers will continue professional leadership in data-driven instruction and differentiated learning.

She also highlighted EL Education's work with character and that the MS reduced major incidents from 430 to 91 last year. Reaves ended the session with an overview of the timeline for ASPIRE.

Session III: Strategic Plan Goal #2 & Goal #3

Following lunch, Executive Director Reaves shared how progress will be monitored on the Strategic Plan through stocktakes and how the Board would receive updates on the Strategic Plan.

Closing Remarks

Executive Director Reaves shared the upcoming meeting cadence and invited Trustees to TR20 events including Back to School Social, Anniversary Festival, Gala, and Alumni Night. She also thanked Trustees for their conversations during the retreat.

The meeting adjourned at 2:22 pm.
